2024-2025 UNACCOMPANIED YOUTH & HOMELESS VERIFICATION

On your 2024-2025 Free Application for Federal Student Aid (FAFSA), you indicated you were an unaccompanied youth who was homeless or self-supporting and at risk of being homeless at any time on or after July 1, 2023.

- **Homeless** means lacking fixed, regular, and adequate housing, which includes living in shelters, motels or cars, or temporarily living with other people because you had nowhere else to go. Also, if you are living in any of these situations and fleeing an abusive parent you may be considered homeless even if your parent would otherwise provide support and a place to live.
- Unaccompanied means you are not living in the physical custody of a parent or guardian.
- Self-supporting means you pay for your own living expenses, including fixed, regular, and adequate housing.

Option A: Attach Documentation Verifying Homelessness or Risk of Homelessness:

Attach documentation from one of the following:

A school district homeless liaison.

A director or designee of an emergency shelter or transitional housing program funded the U.S. Department of Housing and Urban Development.

A director or designee of a runaway or homeless youth basic center or transitional living program.

To confirm:

You are an unaccompanied homeless youth.

• This means you are living in a homeless situation as defined by Section 725 of the McKinney-Vento Act, and are not in the physical custody of a parent or guardian.

You are unaccompanied, self-supporting, and at risk of homelessness.

• This means that you are not in the physical custody of a parent or guardian, you provide for your own living expenses entirely on your own, and are at risk of losing your housing.
